I/We are aware of the risk of all dangerous conditions associated with boating and participation in fishing tournaments and waive any and all specific notice of such conditions. I/We also agree that the Sallisaw Chamber of Commerce shall have exclusive right to use any photographs and video/audio recordings of myself/us as contestant(s) to use in any manner the Sallisaw Chamber of Commerce so chooses.
